1) Official Opening Remarks

Theresa welcomed everyone to the Annual General Meeting, confirmed there was quorum, and noted that the agenda, reports, and minutes are posted on the CAPT website. Sadly, on July 5, 2019, Monica passed away. She was a loving wife and mother of two sons and a daughter, used her skills to help many children, and showed an interest in working with autism.

To receive this Award, the recipient(s) must have made a significant impact and exceptional contribution to play therapy through dedication, competence, and exceptional performance in one of the following areas: outstanding clinical work using play therapy, research related to play therapy through a book, article, or paper, community and committee work, or exceptional contributions to the lives of children.

This year's Award was presented by Lorie Walton on behalf of CAPT to two very deserving candidates, Kip and Elizabeth Sharpe. Lorie described that in 2008, the Board was given the mission to expand play therapy work across Canada. The Board needed to find a management team to expand, grow and support the work of CAPT. They found Kip and Elizabeth who have inspired and connected with CAPT, with a vision for CAPT. Their commitment to the play therapy community across Canada was and continues to be inspirational. They have furthered

Helena highlighted the challenges of the past year with respect to the COVID-19 pandemic, and how CAPT not only survived but thrived during an exceptionally difficult year. At the end of 2020, CAPT revenue increased by \$92 159. This will provide CAPT with a reserve fund to cover the operating costs for one year.

8) Committee Report Highlights

Theresa thanked everyone for their time and commitment to CAPT committee work.

Certification Committee – Chair Hannah Sun-Reid updated that this committee meets monthly and has been working on many tasks. The committee has reviewed many certification applications and certified 12 CPT's, and 4 CPT-S's. Congratulations to the newly certified play therapists and play therapist supervisors in Canada for 2020! The committee has completed two file reviews, responded to multiple email inquiries regarding certification standards and procedures, continues to work on the supervisor handbook, has made adaptations to application process due to COVID-19, rewrote entire certification standards and process (in draft form) to make it simpler and clearer, and continues to work on FAQ's document.

Education Committee – Co-Chair Jodie Hiebert highlighted the online offerings of CAPT Foundation training. She recognized the dedication of CAPT instructors to adapt to allow for CAPT to offer online training during the COVID-19 pandemic. There also continues to be specialized advanced trainings offered online.

Membership Committee – Chair Maya Sloan updated on the work being done by this committee including tracking who is renewing their membership and promotional discounts for the CAPT membership. Maya will be stepping away as Chair of this Committee for the upcoming year.

Research Committee – Chair Dr. Nancy Riedel Bowers highlighted the research award of \$500 given out last year, which will be given out again next year. She discussed collating research articles in books published, and dissertations completed with respect to play therapy in Canada over the years to put as a resource on the CAPT website.

Approved Provider Committee – Chair Tina Katsikeros acknowledged that committee member Kimberley Blackmore has put a tremendous amount of work into completing certifications for approved providers. There were over twenty-one trainings approved over the past year. Some joint meetings have also occurred between Approved Provider, Education and Certification Committee.

Diversity and Inclusion Committee – Although there is a shared responsibility for the Chair position, Donna Starling provided the update at the AGM. This committee is seeking new members. This committee started as an ad hoc committee but is now a standing committee. The focus is on the need for meaningful action with respect to diversity and inclusion in Canada. The committee is looking at offering more diversity in the trainings and is in the process of developing a comprehensive inclusion statement.
